# 1. Regional Situation Updates

No significant regional updates at the moment.

## 2. Updates from partners

#### UNICEF

- COVID-19 Distribution of supplies is ongoing. 20,000 GeneXpert cartridges and swabs received in December 2020 have been confirmed delivered to 16 Pacific Island Countries or Territories (PICTs).
- Tropical Cyclones (TC) Yasa and Ana WASH and Education items were transported to Fiji via Australian
   Defence Force and WFP contributing to 25 metric tons currently being dispatched to partners in Fiji.
- UNICEF continues to experience challenges in transporting humanitarian cargo and personnel throughout
  the region due to the reduced access to commercial services resulting from the pandemic. Any
  commercial services which are available also cost much higher than prior to COVID-19. Creativity and
  partnerships within the cluster are necessary to overcome these challenges.

### MFAT

• For TC Ana, MFAT is monitoring the response and sent relief packages. Details on the latter to follow.

#### **BHA**

 BHA is also monitoring the cyclone response operations and is preparing to mobilise early recovery funding.

#### WFP

- Since August 2020, WFP has moved 1,550 cubic metres of cargo and 98 passengers to 11 PICTs on 29 flights.
- Two Global Passenger flights were conducted since the last period:
  - Kuala Lumpur Port Moresby Nadi on 20 January 2021;
  - o Nadi Port Moresby Kuala Lumpur on 21 January 2021.

# 3. Pacific Logistics Cluster Updates

#### Coordination

- Meaghan Barry is returning shortly as PLC Coordinator.
- The next coordination meeting will be held on 5 March 2021 at 1300 Suva time over Teams as usual.

#### **Common Services**

- Pacific Humanitarian Air Service (PHAS) conducted three flights since the last meeting:
  - From Brisbane to Nadi to Honiara (Solomon Islands) to Brisbane on 26 and 27 January to move approximately 6.902 mt or 45.411 cbm of humanitarian cargo;
  - From Brisbane to Nadi to Port Vila (Vanuatu) to Brisbane on 29 January to move approximately
     4.792 mt or 33.407 cbm of humanitarian cargo;
  - From Brisbane to Nadi on 4 February 2021 to move approximately 10 mt of UNICEF's WASH and
     Education items for the TCs Yasa and Ana response operations.
- The following flights are being planned:
  - Passenger: Kiribati, Republic of the Marshall Islands (RMI), Tuvalu, the Solomon Islands and
     Papua New Guinea;
  - o Cargo: Samoa, Tokelau, Tonga Tuvalu, Niue and Cook Islands.
- The transit warehouse in Nadi continues to be utilised by partners.
